1 Background

- 1.1 A letter has been received from Ian Fytche at North Kesteven District Council who, on behalf of Lincolnshire district council Chief Executives, is seeking an elected member nominee from each district to sit on a newly established District Health and Well-being Network. DISTRICT HEALTH AND WELLBEING NETWORK


I am writing to invite you to nominate a Councillor from West Lindsey District Council to join a District Health and Wellbeing Network for Lincolnshire.

In recent meetings, we have nominated one District Councillor (Cllr Marion Brighton OBE) to represent the interests of District Councils on the countywide Health and Wellbeing Network. We also discussed (at the Leader/CX meeting in Boston) the potential to set up a health and wellbeing network for District Councils, to provide the opportunity to co-ordinate health and wellbeing issues across the county.
