1. Introduction

- 1.1 The former Planning Committee has requested that an update report be brought to Committee on a quarterly basis as the information in this report directly relates to Development Management it will now be presented to the Development Management Committee.
- 1.2 This report provides information regarding the enforcement service between April and June 2011.

2. Current Caseload

- 2.1 There are currently 148 matters shown as open on the database. This figure includes mattes where formal notices have been served and are either within time for submitting an appeal or within the timescale for compliance. **Appendix 1** This is down from over 350 cases at the beginning of April 2010 and represents a manageable workload. The priorities set out in the Enforcement Policy. Adopted in February 2010, are under review and the results of this review will be discussed with Councillors at a seminar to be held on 31st August in the Council Chamber. Details of this seminar will be circulated nearer date.
