## 1. Information

- 1.1.Over the last two years, the Challenge and Improvement Committee Tourism Working Group have been reviewing activity underway related to tourism in West Lindsey with a focus on 'creating local wealth through the visitor economy'.
- 1.2. There was strong consensus that more should be done to develop the visitor economy in West Lindsey and the group have recommended that further work should be undertaken to with the specific objectives of:
  - Increasing number of visitors / length of stay
  - Increasing expenditure by visitors
  - Developing leisure, culture and recreational offer
  - Increasing the quality and number of businesses / jobs in the sector

## 2. Recommendation to Prosperous Communities

- 2.1. The visitor economy is identified as a priority within the approved Economic Growth Strategy.
- 2.2. As any further development in this area falls outside of the remit of the Challenge and Improvement Committee, the Working Group makes the following recommendations to the Prosperous Communities Committee as the committee responsible for business growth, job creation and community development:
- That the visitor economy is seen as a priority for the Council with a focus on the objectives outlined in paragraph 1.2.
