Greater Lincolnshire Leadership Board

Minute extract from 25 January Council

"Councillor Giles McNeill questioned one of the items in that an update would be welcomed, namely the two appointments of one Member on the Greater Lincolnshire Leadership Board, and whether this had been discussed any further by the Board." Response received from the Joint Committee "The constitution we have issued is for the Joint Committee – it is not changing any constitutions of any of the 10 local authorities. The "shadow" Joint Committee has been formed to formalise the meetings held by the Leaders and to oversee a governance review (if that proceeds).

The Joint Committee has no finances and therefore any resource required will be met by the constituent (10) authorities. Boston Borough Council have kindly agreed to provide administrative support at the meetings (as they currently support the Leaders meetings).

Baroness Redfern is the lead councillor for the Governance and Finance workstreams of the devolution deal work currently being done. Baroness Redfern will not be reviewing the constitution or finances of any of the ten councils.

 The devolution discussions amount to a programme of activity that needs to be managed and led effectively.
In order for the programme governance to be inclusive and responsive to the roles/responsibilities of Leaders and Chief Executives, the Leaders agreed that programme sponsorship should have Leader and Chief Executive involvement.

- The Leaders agreed to the respective Themes within the programme to have a Chief Executive lead , accountable to a designated Leader from the 10 Authorities.

- The arrangements that have been operating are as inclusive as practicable of both Leaders and Chief Executives and subject to review at the GL Leaders meetings.

- Rob Walsh (CX, NELC) has stated that in his opinion the arrangements do not raise conflict of interest issues as the focus is on programme development and oversight"
