#### **45 CONSIDERATION OF ALDERMAN NOMINATIONS**

The Head of Central Services presented Members with a report asking Council to consider received nominations for the titled roles of Honorary Alderman.

Appointing to these positions was a power given to Councils, and it was their decision whether they wished to exercise these powers or not. It was a right given that nominations could be received by Councils, and therefore a process and criteria needed to be defined in order to manage a received nomination. The roles, limitations, criteria and processes for the titles of Honorary Alderman, Honorary Freeman, and Honorary Freedom of Entry had been agreed in January 2013, after much debate in Member meetings, Committees and Council.

Two nominations had been received and managed through the agreed process and were presented to Council for consideration of whether they wished to bestow the titles to the nominees.

The proposers of each of the nominees spoke briefly to describe why they felt that the nominations were deserved and worthy of recognition, and the sentiments were echoed by some other Councillors. Clarification was sought as to the possibility of removal of the honour should the need arise in a case of misconduct, this was affirmed.

Cllr McNeill wished for thanks to be recorded for the work of the Honours Panel.

Two Members of the Council called for a recorded vote.
