1 Background – Food Service Plan

- 1.1 The Food Plan was agreed by the Licensing and Regulatory committee on the 24th June 2014. At this meeting it was agreed that an update report would be provided to keep members informed as to progress of the pre-planned monitoring visits.
- 1.2 Between April and August 2014 165 pre-planned inspections were targeted to be completed, of these we achieved 156 (95%).
- 1.3 The risk to the Authority if the situation were to continue is that we would not achieve the inspection rate targeted in the Food Plan.
- 1.4 The number of inspections is slightly below target due to staff illness in August which meant that only 26 out of 33 inspections were completed that month.
- 1.5 Even though we are slightly below target officers feel that this position can be improved upon before year end, as this data is the position after five months.
- 1.6 The number of inspections undertaken will continue to be monitored and should the required amount of inspections continue to decline in the next three months, officers will consider what options to implement (if any).
- 1.7 Consideration would be given to:
 - Overtime for officers,
 - · Approaching other local authorities, or
 - The use of external resources

To undertake the necessary inspections in order to achieve the target.

2 Conclusion

- 2.1 In conclusion, taking into account the small deficit in inspections, your officers recommend that, at this stage, progress for a further three months continue to be monitored and no remedial action is needed at this moment in time. However, if the target is still not being met after that point then the above options will be considered.
- 2.2 Furthermore if future performance falls below 95% a further progress report will be brought to Committee for consideration.
