## 16 APPLICATION FOR COMBINED HACKNEY CARRIAGE / PRIVATE HIRE DRIVER'S LICENCE (TGL. 07 14/15)

The Chairman welcomed all present to the meeting and round the table introductions were made. The Principles of Natural Justice were followed. Confirmation was sought that the Applicant was aware that he could have been represented at the meeting, this was affirmed.

Members considered a report which detailed an application for the grant of a combined hackney carriage / private hire driver's licence for an Applicant who had a number of convictions for offences. The Sub-Committee were asked to determine whether or not the Applicant was a 'fit and proper' person to be issued a licence.

The Sub-Committee posed a number of pertinent questions to the Applicant during which the Applicant explained the circumstances of the incidents of which he had been convicted and assured the Sub-Committee that he now had a child, and no longer put himself into the situations under which the incidents had occurred.

The Licensing Team Manager and the Applicant were both provided with the opportunity to sum up their cases during which it was noted that there was no definition of "fit and proper persons".

The Licensing Team Manager, the Licensing Officer and the Applicant withdrew from the meeting whilst the Sub-Committee debated the matter. They were subsequently recalled to the meeting and informed of the decision as follows: -

The Taxi and General Licensing Sub-Committee carefully considered the evidence presented and were of the opinion that the criteria in the Council guidelines and the test of fitness and propriety is satisfied and that the licence as applied for by the applicant should be granted.

RESOLVED that the application be granted with a strict warning in relation to future conduct and if in the future the applicant was brought in front of the Sub-Committee for any breaches, the licence could be revoked.

There was a right of appeal to the Magistrate's Court within 21 days.
