## 1. Introduction

- 1.1 The Council is required under the Local Government Act 1972 to produce a schedule of its meetings. The Corporate Policy and Resources Committee is responsible for approving that timetable (schedule) annually, having approved the timetable for 2023/24 at its meeting on 9 February 2023.

## 2 Reason for Change

- 2.1 West Lindsey District Council has been nominated for the LGC Council of the Year Award, the ceremony for which is scheduled to take place on Thursday 8 June 2023. This is the date of the currently scheduled meeting of the Corporate Policy & Resources Committee.
- 2.2 In order that arrangements may be made for Senior Managers and/or Members to attend the Awards Ceremony to represent the Council, it has been suggested that the date of the Committee meeting be amended. This is to allow greatest flexibility when considering attendees at the event.
- 2.3 Both the scheduled meeting, and the Awards Ceremony, are due to take place during the Member Induction period post Elections. Additionally, there is already a three-month period between the last meeting of 2022/23 and the first meeting of 2023/24, owing to the Pre-Election period (purdah). For these reasons, options are limited for rescheduling the meeting to take place as usual on a Thursday. Therefore, the proposed date for the re-scheduled meeting is Wednesday, 7 June 2023
- 2.4 Whilst the Head of Paid Service has a number of delegations in relation to the Committee timetable, as set out at page Part IV- Page 32 of the Constitution, namely:

“9. In the event of extreme inclement weather; or insufficient business to warrant calling a meeting or other unforeseen circumstance including periods of national mourning/national emergencies to **cancel or postpone** a meeting of the Council, a committee, subcommittee etc. or, where business dictates that a **meeting, not already set out in the timetable, be required** to be held, that meeting be called, in consultation with the relevant Chairman.

This delegation does not extend to changing already approved dates, in order that the delegation does not compete with the legal requirement to produce a schedule of meetings (ref 1.1 above).

## 3. Recommendation

- 3.1 In order to ensure options for attendance at the Awards Ceremony, and to minimise disruption to the Member Induction Programme, the

Corporate Policy and Resources Committee are therefore asked to approve the following change to the previously agreed timetable:

- a) the meeting of the Corporate Policy and Resources Committee currently scheduled for Thursday, 8 June 2023, be moved to Wednesday, 7 June 2023.
