## **15 REVIEW OF THE CONSTITUTION (PAPER G)**

The Strategic Lead for Democratic and Business Support and Monitoring Officer introduced the report which set out the process to be followed in reviewing the Constitution annually. Those changes recommended for approval by Council were set out in Section 2 of the report, and also listed were amendments made in-year and approved by the Governance and Audit Committee, as agreed by Council on 21 May 2015.

Further work was proposed by the Governance and Audit Committee both relating to the Planning Committee and future Governance arrangements of the Council.

- The pre-application process and protocol
- The Committee referral process ie the Scheme of Officer Delegation for this area; and
- Officer involvement in the Appeals Process

Work on the above items to be submitted for approval by the Governance and Audit Committee.

It was further recommended that Council commission the Monitoring Officer, with support from and through the Governance and Audit Committee, to undertake further detailed evaluation work into the implications of a possible move to the leader cabinet model, and submit recommendations to full council during autumn 2016. However debate ensued on the merits or otherwise of Cabinet models, and the fact that this had been debated and voted upon in the past. It was acknowledged that some Councils were now moving away from Cabinet systems and returning to Committee led authorities, although it was agreed that the Council's decision making process could be improved. Members who had attended the recent workshop acknowledged its usefulness and it was noted that at this stage it was evaluation work to consider the options that was being proposed.

It was therefore proposed that recommendation e) be amended to include the words "hybrid or better Committee system" after the "leader cabinet model".

The above amendment was seconded and subsequently voted upon.

The recommendations, including the above agreed amendment were then moved and seconded en bloc and voted upon.

- e) That Council commission the Monitoring Officer, with support from and through the Governance and Audit Committee, to undertake further detailed evaluation work into the implications of a possible move to the Leader Cabinet model, hybrid or more effective Committee System, with a view to achieving the outcomes set out below ((i) – (vii)) relate and submit recommendations to full Council during autumn 2016.
  - (i) Speed of decision making – The Council's Decision Making process allows it to take advantage of opportunities on commercial projects and ensure that WLDC can work as quickly as its colleagues in Greater Lincolnshire
  - (ii) Empowering Individuals – Those members charged with representing the Council with partners have the authority to act and take responsibility for the decisions they make.
  - (iii) Effective Council governance and roles of Members and Officers - to ensure the Council has maximum influence and impact with any potential Mayor and Combined Authority to the benefit of West Lindsey.
  - (iv) Specialist Knowledge – Members have the knowledge and skills to make good, well informed and safe decisions

- (v) Transparency – Governance arrangements which ensure residents can see that decisions are made reasonably and fairly.
- (vi) Accountability – There is clear accountability for success and failure for both members and officers
- (vii) Involvement – Members are able to set policy and take ownership of key decisions.

## **16 CHALLENGE AND IMPROVEMENT COMMITTEE ANNUAL REPORT (PAPER H)**

The Chairman of the Challenge and Improvement Committee presented the report which summarised the work done by the Committee in the preceding year and its proposed workplan for the future, and thanked all the Committee Members for their support and involvement.

**RESOLVED** that the Challenge and Improvement Committee Annual Report 2015/16 be noted.

## **18 CENTRAL LINCOLNSHIRE LOCAL PLAN SUBMISSION DRAFT (PAPER J)**

The Leader of the Council introduced the report which provided an update on the final stage of the Local Plan consultation and recommended that Members supported a formal consultation response that endorsed the Proposed Submission Draft Local Plan.

**Note** Councillors Cotton and Curtis declared an interest in the report as being members of the Central Lincolnshire Joint Strategic Planning Committee.

The Leader noted that the Plan had a vision for sustainable growth for the area and had a presumption in favour of development whilst also giving protection to communities from inappropriate development. The benefits of Neighbourhood Planning were described which put local people at the forefront of decision making. Working on a vision for sustainable growth for Lincolnshire the Plan provided a platform for a settlement hierarchy. 53 policies in the Plan provided guidance on all aspects of development.

The Leader expressed his thanks to officers and fellow Members for their work over the previous two years' work, and recommended the report for approval.

On being seconded and voted upon it was:-

**RESOLVED** that:

- a) Members welcome the publication of the Proposed Submission Draft Central Lincolnshire Local Plan, recognising the framework for strong economic growth it provides, in that it:
  - i. Provides a statutory spatial planning framework for the regeneration, growth and development of Gainsborough in accordance with the corporate aspirations this Council has for the town.
  - ii. It assists with the use of major infrastructure assets present in the District to further jobs growth and economic prosperity within the District
  - iii. It enables the growth and development of our market towns
  - iv. It gives (through the provision of a five year housing land supply) appropriate protection to those areas within the District where further housing growth would damage the identity of communities and put a further strain on existing infrastructure
  - v. It gives support to communities who desire to see their areas grow by providing a framework within which Neighbourhood Plans can be prepared.
  - vi. It enables some of the smallest settlements in the District to grow at a scale appropriate to their needs.
- b) Council endorse the Proposed Submission Draft Local Plan and that authority be provided to the Chief Operating Officer and Leader of the Council to submit a formal representation to the Central Lincolnshire Joint Strategic Planning Committee and Local Plan team giving full WLDC support to the Proposed Submission Draft Local Plan (and therefore for the plan to proceed to Examination in Public and then adoption).

## **21 MEMBERS' DECLARATIONS OF INTEREST**

Councillor Ian Fleetwood declared that he was a Lincolnshire County Councillor, and that LCC had agreed the report the previous week.

## **22 GREATER LINCOLNSHIRE DEVOLUTION PROPOSAL (PAPER A)**

The Leader of the Council introduced the report, reminding Members of the process to date. Council had received the Greater Lincolnshire Devolution Deal Interim Governance Proposal and the then latest version of the deal document at its meeting on 16 November 2015. Council approved that the Greater Lincolnshire devolution expression of interest, submitted to Government on 4 September 2015, should be developed into a fit for purpose devolution deal document via continued formal engagement with Government and that authority was delegated to the Leader and Chief Executive to continue devolution discussions and negotiations with Government.

These discussions and extensive work culminated in the Devolution Agreement being signed by the ten Greater Lincolnshire Council Leaders and Government Ministers. This was formally announced by the Chancellor in the Budget on 16 March.

There were clear statutory processes that needed to be followed in accordance with the Cities and Local Devolution Act 2016 to establish a mayoral combined authority and devolving appropriate powers from central government for May 2017. The Greater Lincolnshire deal was one of the first to be progressed under this legislation.

The constituent councils needed to undertake a governance review, publish a scheme as to how a mayoral combined authority would work, undertake a statutory public consultation on the scheme and provide a summary of the consultation responses to the Secretary of State. The primary purpose of a governance review was to set out the rationale for creating a Greater Lincolnshire geographic/economic footprint and to propose options for governance. The governance review and the consultation on the draft scheme would enable the Secretary of State to decide whether the statutory tests on improving the exercise of functions were met and whether it was appropriate to make the order (if parliament approved) establishing the Mayoral Combined Authority. Before making such an order, consent needed to be sought from the constituent councils.

The report set out the terms of the governance review and the scheme on which consultation would take place. Each council was to receive the attachments for consideration by its Full Council and a report inviting the same recommendations at their next scheduled meeting.

The Leader clarified that the report was about gaining approval for public consultation. The ten constituent authorities would work together achieving what National Government could not, in terms of community relationships. Devolution was seen in the same way as Neighbourhood Plans by taking local control and funding from Government. It was vital to appoint a mayor as the offer would not be worth taking without. The ten leaders had met with Greg Clarke, but once a mayor was in place that person would speak on behalf of all the authorities. Whilst there would be a cost this was anticipated to equate to a minimal precept per household.

Benefits would be physical and social as well as financial, and the bid would grow and multiply, with further proposals in the next submission. Each authority would have one vote on an equal basis, and each Council would continue as before with its current responsibilities. The combined authority would only have responsibility for a set agenda or on issues which affected the whole of Lincolnshire which all members felt relevant.

The Leader of the Opposition echoed the statements of the Leader and stated that it was important to have a vision and move forwards. Lincolnshire was a large area but with a low population so had limited strength against other parts of the country, however now was the chance to take control. Health and the road network could be issues covered in the future.

Lengthy debate ensued with varying views being expressed and clarification sought on a number of points.

Some Members were not in favour of the position of elected mayor, as this had previously been rejected by West Lindsey, however this post was to be a spokesperson for the combined authority, not about the governance of the District

Council. It was felt that the benefits of the deal were being blurred by the resistance to the post of mayor and Members should let MPs know their feelings about the imposition of the post.

Questions were raised about the level of consultation and the influence that this would have. The Chief Executive confirmed that a communications plan was being developed and whilst no dates had yet been set it was proposed to hold workshops for Members in order for them to be fully informed to cascade information to the electorate. It was important for the public to receive information regardless of their Ward Member's views.

It was noted that the current system of government had been in existence for a great many years and it was important to move forwards and achieve the best deal possible for Lincolnshire. Devolution was evolution.

The distribution of resources would be fair and equitable, and directed to where most benefit would be achieved, by a collective decision, with one vote each per constituent authority.

The recommendations in the report were moved and seconded en bloc, and in accordance with the Constitution Part V, page 11, paragraph 14.4, two Members of the Council called for a recorded vote to be taken.

  - iii. on the basis of the Governance Review, the council concludes that the establishment of a Mayoral Combined Authority for the Greater Lincolnshire area would be likely to improve the exercise of statutory functions in relation to the area;
  - iv. accordingly, the council supports the preparation and publication of a Scheme for the establishment of a Mayoral

- Combined Authority for the Greater Lincolnshire area under section 109 of the Local Democracy, Economic Development and Construction Act 2009;
- v. the publication of the draft Scheme for a Greater Lincolnshire Mayoral Combined Authority as attached to the report for consultation purposes, subject to such final revisions as may be approved by the Chief Executive, in consultation with the Leader, prior to commencement of the consultation exercise be supported;
  - vi. the outcome of the consultation exercise be reported to the next meeting of the council;
  - vii. council meets by 20 October 2016 to consider giving consent to an Order establishing a Mayoral Combined Authority for Greater Lincolnshire;
  - viii. insofar as any of the matters referred to in the report concern the discharge of non-executive functions, authority be delegated to the Chief Executive, in consultation with the Leader, to take all necessary steps and actions to progress the recommendations detailed in the report; and
  - ix. further reports be presented to Council as appropriate as the Devolution process develops.

## **1. Introduction**

- 1.1 At Prosperous Communities Committee on 29<sup>th</sup> October 2015 it was resolved that a Member Working Group for Rural Transport be established to assist officers in working up projects. The following names were put forward:
- Councillor Lewis Strange
  - Councillor Lesley Rollings
  - Councillor Di Rodgers
  - Councillor Jessie Milne
  - Councillor Steve England
  - Councillor Paul Howitt-Cowan
- 1.2 At Annual Council on 9<sup>th</sup> May 2016 Paper D set out appointments of Members to committees, boards and other bodies. The confirmation of appointments to the Rural Transport Member Working Group were not included at this meeting due to on-going work to develop rural transport projects.
- 1.3 Following the above meetings Officers have been working to develop further projects and liaise with other stakeholders including Lincolnshire County Council as the Transport Authority. It is now an appropriate time to hold the first Member Working Group meeting for Rural Transport.
- 1.4 Appointments to the Rural Transport Member Working Group must be legally and constitutionally confirmed at Full Council.

## **2. Representatives to serve on other bodies**

- (a) To note that appointments are to be made on the following basis:
- i) In the first instance any Member with a specialist interest or expertise in the particular field of the Outside Body should be appointed (the appointment should not be party political), Failing this, where possible, appointments should be made geographically involving a local Ward Member. Where neither of these criteria can be met, any other Member should be appointed;
  - ii) appointments are generally to be made for a four year period to be in line with District elections. However, a number of bodies have their own arrangements for a four yearly cycle of appointments.
  - iii) where a body shows that the Leader, Chairman and/or Vice-Chairman of a particular committee is the representative, this is because either the constitution of the body concerned requires it or there has been a previous Council decision that the office-holder will serve. Where a body indicates that this has traditionally been the case, there is no actual requirement; and

- (b) to agree that places which have traditionally been filled by the Leader, Chairman and/or Vice-Chairman of a particular committee or their nominee continue to be so filled.
- (c) to agree that appointed representatives should arrange for a reserve (where required) with the exception of those bodies marked with an asterisk \* (as these are directorships and personal appointments).
- (d) to appoint six members to serve on the **Rural Transport Working Group**.
