1 PUBLIC PARTICIPATION

There was no public participation.

2 DECLARATIONS OF INTEREST

There were no declarations of interest at this point in the meeting.

3 MINUTES OF PREVIOUS MEETINGS

RESOLVED that the Minutes of the Meeting of the Regulatory Committee held on Thursday, 22 September 2022 be confirmed and signed as an accurate record.

4 MATTERS ARISING SCHEDULE

In the absence of any further questions, the report was taken as read and with no requirement for a vote, the Matters Arising were **DULY NOTED**.

5 SCHEDULE 4 - ABANDONED SHOPPING TROLLEYS: REVIEW AND CONSULTATION

Members gave consideration to a report which provided a review of the Schedule 4 scheme to-date and proposed consultation on the Scheme's future continuation.

The Council had agreed to implement the Scheme using its powers under the Environmental Protection Act 1990 and it had come into effect in August 2018 for the Gainsborough area. The scheme had been introduced to combat the persistent issue of abandoned shopping trolleys, which at the time were being collected at a rate of 30 per week.

The issue of abandoned shopping trolleys was still present in Gainsborough and the collection rates were now averaging 12 - 13 per week. The first quarter of 2023 had seen the number fall below an average of 10 per week, a reduction of 62% since the implementation of the Scheme.

The report set out the rationale for the Scheme continuing and the consultation process was a statutory obligation on the Authority if they wished to continue, amend or cease the Scheme. The dates and purpose of the Consultation were set out within the report.

Debate ensued, and in response to a query about the type of supermarkets this would apply to, Members learned that the Scheme applied to the larger supermarkets and was not applicable to smaller convenience stores nor more general stores that had trolleys.

Having been proposed and seconded, on taking the vote, it was unanimously

RESOLVED that:-

a) the progress of the scheme to date be noted;

b) the proposals for consultation to take place for a 4 week period commencing Friday 23rd June 2023 be approved; and

c) a further report be brought back to Regulatory Committee in September 2023 to provide the outcome of the consultation and recommend a course of action for the scheme's future.

6 FOOD, HEALTH AND SAFETY WORK PLAN 23/24

Members gave consideration to the Food, Health and Safety Work Plan 2023/24. The Council was required to produce and approve a Work Plan that was in line with the Food Standards Agency (FSA) Framework Agreement and the Statement of Commitment, agreed nationally, between Local Authority Representatives and the Health and Safety Executive.

The Committee therefore considered such a Plan, which covered all work undertaken within the Housing and Environmental Enforcement work area, relating to Food and Health and Safety. The Plan's purpose was to set out how the Council delivered its official controls and fulfilled its duties under Food, Health and Safety, Public Health and Drinking Water legislation.

The Plan before Members also reflected the work conducted over the past municipal year. In terms of inspections, the Authority completed over 90% and the last year signified the end of a challenging period, particularly due to the Covid pandemic, requiring redeployment and temporary resourcing. Section 3 detailed the demand on the Service over the last 4 years .and Section 4 detailed the approach which had been taken to inspections during 22/23. It was anticipated that when accounting for both routine planned and unplanned inspections between 274 and 296 food hygiene inspections would be required in the current financial year.

Section 5 of the report highlighted that additional resources may be needed to ensure that the Councils food hygiene requirements was met, along with its health and safety requirements with Section 7 setting out the actions be taken to address this Members were advised that an update report on progress against the Plan and its targets would be provided to the Committee at its December 2023.

Without any other comment, having been proposed and seconded, upon taking the vote, it was unanimously

RESOLVED that: -

a) the Food, Health and Safety Work Plan as detailed at Appendix 1, be approved.

b) the commencement of a T24 Internal Review of the Food, Health and Safety work area in May 2023, as set out in section 7, be noted.

c) an update on progress against the plan be brought to Regulatory Committee at its December 2023 meeting.

7 DISTRICT WIDE DOG FOULING PSPO

Members gave consideration to the District Wide Dog Fouling Public Space Protection Order (PSPO).

In June 2020 the Council designated its "Dog Fouling Public Space Protection Order", which was in place until the 5th of June 2023. This PSPO focused on dog fouling and disposal and applied across the whole district. It also included a provision for individuals to carry and have available a means to remove dog fouling.

The impact of dog fouling on both the natural environment and on public health was well known. It was essential for the Council to promote responsible dog ownership and to ensure that where this is not the case there was provision, in law, for addressing it. Members

learned that part of the PSPO prior to this report required a consultation period, which had resulted in a wide array of support for an extension of the Order.

The PSPO gave the Authority the power to issue fixed penalty notices and the report proposed that the existing PSPO be extended for an additional three years, with a general acceptance to carry on with ongoing action.

Debate ensued, and Members were appreciative of retaining the existing PSPO. In response to a set of queries on replacing the signage as a deterrent, officers explained that the Authority was happy to provide those replacements. Members also expressed desire for greater collaboration between the Authority and Parish Councils on this matter.

With no further discussion, having been proposed and seconded, upon taking the vote, it was unanimously

RESOLVED that the Dog Fouling PSPO be extended for a three-year period from 6th June 2023 to 5th June 2026.

8 PAVEMENT LICENSES

Members gave consideration to the Pavement Licenses report, which proposed revisions to the powers sub-delegated to Lincolnshire County Council in respect of Pavement Licensing.

In September 2022, the Regulatory Committee had agreed to delegate the District Councils function under the Business and Planning Act 2020 for "Pavement Licenses" to Lincolnshire County Council for a further 12 months up until the 30 September 2023. The Committee had also agreed to delegate the same function until 30th September 2024, subject to the provisions remaining in place. The licenses ran annually, with many businesses taking them out during Covid. It was the Authority's role to ensure the relevant stakeholders were aware, consult, and report to the Lincolnshire County Council.

Prior to this Act pavement licences (also known as "street café licences" and "tables and chairs licences") which allowed businesses such as cafes, restaurants and bars to place furniture on the highway were determined by Lincolnshire County Council (LCC) under the Highways Act 1980.

Since September 2022, the Government had been seeking approval for the Levelling-Up and Regeneration Bill (The Bill), which would now include the provisions for Pavement Licenses and would allow the Licensing Authority to charge a fee for the service. As such this required an amendment to the delegation in place

Members heard of the two options available, which were to either continue with, and amend the sub-delegation to enable the charging of fees as per the Bill, or to cease the subdelegation and deliver the service in house. Members noted the number of licences were small, whilst the cost of introducing a new service could be considerable. As such it was being recommended that the delegation be amended to allow continued delivery by the County Council. Assurance was offered that the Committee would continue to have the ability to review this arrangement at least annually. With no further comment, having been proposed and seconded, upon taking the vote, it was unanimously

RESOLVED that: -

a) the Districts Council's function in relation to "Pavement Licenses" under the Business and Planning Act 2020 and subsequently the Levelling Up and Regeneration Bill be delegated to Lincolnshire County Council until September 2024;

b) Lincolnshire County Council be permitted to set and charge a fee of up to £500 for a new licence and £350 for a renewal under the delegation granted above until September 2024; and

c) a summary of the delegation relating to Pavement Licenses be presented to Regulatory Committee annually and any further delegations considered within these reports.

Committee are asked to:

- a) Note the results of the consultation carried out between 23rd June 2023 and 21st July 2023.
- b) Agree that the Environmental Protection Act 1990, Schedule 4 scheme relating to abandoned shopping trolleys in Gainsborough is continued and that the charges remain as shown in the schedule in appendix 1.
- c) Agree that Officers, in conjunction with the Chair of the Committee engage with the supermarkets in the area that are responsible for the largest volume of abandoned trolleys to ensure that they are aware of the outcome of the consultation and are taking steps to reduce the impact locally.
- d) Agree that the scheme is reviewed again by committee in 5 years' time, during 2028 and that an annual update is provided to Chairs Brief from 2024 onwards.

IMPLICATIONS

Legal:

The Council adopted this schedule at a meeting of the Prosperous Communities Committee on the 1st of May 2018 and it came into effect on the 17th August 2018.

The provision for adopting this schedule is provided with the Environmental Protection Act 1990, schedule 4.

The legal requirements as stated in the Act have been complied with. Previous legal challenges in other areas of the country have not been upheld.

Financial:

The main income from this scheme is in the form of charging for each trolley recovered, claimed and paid for, and returned to store. The full charging schedule for the scheme is shown in appendix 1.

The table below details the income received in the last 5 years.

This income has supported the Street Cleansing service costs for collecting these trolleys. A budget of £18.7k has been built into the Street Cleansing budget for each year. If this scheme was to be discontinued this would create an ongoing pressure of £18.7k pa on the Street Cleansing Service budget.

Staffing :

This function is delivered as part of the Council's ongoing street cleansing operation. Reporting of abandoned shopping trolleys is undertaken by both the street cleansing and enforcement teams.

Equality and Diversity including Human Rights :

Climate Related Risks and Opportunities :

The clearance and return of the trolleys help to ensure that they can be reused for the intended purpose and reduces the volume that may otherwise end up as general waste for landfill.

The CESIA wheel below indicates that the scheme is having a positive impact on the climate for the Council. It is bringing in additional income for the Council, whilst at the same time ensuring that an environmental issue is addressed.



Section 17 Crime and Disorder Considerations :

Prior to the scheme, trolleys presented a general concern in regard to their volume and their use for activities that constituted anti-social behaviour. The collection of trolleys seeks to reduce this impact.

Health Implications:

Ensuring that the street scene is clear of trolleys contributes to the enhancement of the space within the area, which in turn helps it to be an aesthetically better place to be. Likewise, the collection of any abandoned trolleys is done in turn with other waste collection, which also contributes to this.

1 Introduction

- 1.1 The Council has agreed to implement this scheme using its powers under the Environmental Protection Act 1990 and it came into effect in August 2018 for the Gainsborough area.
- 1.2 The scheme was introduced to combat the persistent issue of abandoned shopping trolleys, which at the time were being collected at a rate of 30 per week.
- 1.3 The scheme is operated and managed by the Street Cleansing Team with support from Enforcement Officers.

2 Scope of the Scheme

- 2.1 The scheme seeks to make supermarkets more accountable and responsible for the trolleys that leave their premises and in turn provides a mechanism for the Council to charge for their recovery and return. Appendix 1 sets out the charging schedule.
- 2.2 The scheme does not provide a solution that resolves the issue of abandoned shopping trolleys, it provides a mechanism to recover the cost of clearing them, which in turn, should encourage supermarkets to take more steps to reduce the issue occurring.
- 2.3 Prior to the scheme being introduced the Council were collecting the trolleys and either storing or returning them at its own cost.

3 Governance

- 3.1 Under the legislation, the Local Authority has an obligation to consult about the operation of Schedule 4 and "to consult with the persons or representatives of persons who appear to the authority to be persons who will be affected by its application".
- 3.2 This consultation has now been completed and the results included within this report.

4 Consultation Outcome

- 4.1 The Council undertook consultation on the matter between the 23rd of June and 21st of July 2023. The consultation was done via an online survey and was publicised via the Council's social media. Promoted with all Councillors and local supermarkets were also contacted directly and given an opportunity to respond to the Council.
- 4.2 There was a significant degree of media interest in the consultation with both the written and tv media running articles on the story during the consultation.
- 4.3 The main results of the survey are shown below, and a copy of the overall results are shown in appendix 2.

Page 12

- 132 responses were received.
- 95% of these responses were from residents.
- 75% of respondents believed abandoned shopping trolleys are an issue in Gainsborough.
- 87% of respondents believed that the Council should continue the Schedule 4 scheme.
- 62% of respondents agreed with the proposed charges. 22% believed they should be higher.
- 4.4 There was only one response to the survey sent directly to supermarkets. The responder was unsure if it was an issue, however they did support the scheme and the proposed charges.
- 4.5 Appendix 3 shows an overview of the main themes that were raised in the consultation and where appropriate a response have been provided to comments that have been made.

5 Summary

- 5.1 There is a clear desire for the Council to continue to deliver the scheme based on the response to the consultation.
- 5.2 The charge currently scheduled is believed to be appropriate and is proposed to remain the same.
- 5.3 It is proposed that officers, in conjunction with the Chair of the Committee seek to engage with the supermarkets in the area that are responsible for the highest volumes of trolleys to ensure that they are aware of the feedback given and that they are pressed to look at other solutions on the ground to reduce the volume of trolleys remove from the store.
- 5.4 It is proposed that the scheme is reviewed again in 5 years' time, during 2028, and that an annual update is provided to Chairs Brief from 2024 onwards

Appendix 1

West Lindsey District Council Schedule 4 EPA 1990 scheme

<u>Scope</u>

Trolleys found abandoned in Gainsborough will be seized by West Lindsey District Council ('the council') and removed to the council depot in Gainsborough for storage.

Once a trolley has been seized the council will notify the owner, if identifiable, within 14 days. If the owner claims the trolley, the council will deliver the trolley back to the store once the payment for release has been made.

If the trolley is not claimed or payment not received the council will store the trolley for 6 weeks, after which the trolley will be disposed of. The owner will be charged for the costs of recovery, storage and disposal.

If no owner can be identified the council will store the trolley for 6 weeks, then dispose of it. The scheme will apply to all supermarkets who supply shopping trolleys in Gainsborough.

Charges

Our charges are set out below (stated fee is per trolley):

- Trolley recovered, claimed and paid for, and returned to store	£75

Make the supermarkets take the trolleys in at night time so people don't take them and then dump them

CCTV in trolley hotspots

Supermarkets could elevate abandoned shopping trolleys if they put restrictors on the trolleys which stop them going past a selected border around the supermarket. West Lindsey should suggest this investment to Supermarkets could save money and time in the long run!

I don't think a £100 charge is enough to make the major supermarkets come up with an idea to stop there trolley being taken, but a £1000 charge per trolley would force the company to come up with an idea \P to stop there trolleys being taken off the premises.

Track who took them and charge them (criminally and financially)

Promotion of personal shopping trolleys/bags to those that take shopping home in supermarket trolleys. People having to put money in a trolley should also deter it.

Use CCTV to capture individuals throwing trolleys into the river

Ask supermarkets to install the trolley boundaries ensuring trolleys can't be taken off the premises. Saves you a job and them the cost. If they don't agree to implement charge them £100 per trolley.

Supermarkets could go back to a deposit on the trolleys

Why is it a council problem? Abandoned trolleys should be treated like any other scrap metal dumped in the street. It is the onus of the loser to report the loss or theft of an item to the police - it is up to them to place identifying markings on the trolleys so that they can be reclaimed - if neither of these actions take place they should be scrapped after 28 days.

Fine the people that dump the trolleys. With all the cameras that have gone up lately, surely the culprits can be caught.

perhaps using another organisation. The company used is very difficult to deal with when making representations to them. Very unhelpful.

Maybe food outlets should be charged for their debris!

It's mainly Tescos trolleys I see. Maybe they should introduce the £1 charge like the others do

Maybe go back to having to put pound in trolleys

I wish I could cos charging supermarkets only increases our weekly shopping bill as does shop lifting.

Ideally the person who dumps them should be fined but that would be difficult

Supermarkets make huge profits, none of which are passed on fairly to food producers or customers, so charge them the absolute maximum that you can for returning their trolleys; you rarely see the ones that are coin operated abandoned, it's the free to use ones - these supermarkets are doing nothing themselves to reduce removal of trolleys. (The wheel locking systems don't work, you only have to steer a few inches off course to bypass them!) I live on Washington Street and there are always loads around there and all along Sandsfield Lane area up as far as Tesco.

If there are certain areas of the town which abandoned trolleys are more of a problem could a scheme be set up that involves people/children to collect them for a fee who live in that community.

Wardens at exit to supermarkets to prevent removal

Engage with supermarkets to put better practices in place to stop trolleys leaving their sites in the first place.

If possible fine the ones who remove them by looking on cctv,

Why would you do anything different its clearly working because I don't think there is an issue with shopping trolleys in Gainsborough.

Are there any other methods you think West Lindsey District Council should consider to tackle this issue?

Checking CCTV and if possible fining customers who abandon their trolleys rather than the supermarkets

Task the supermarkets with the job of collecting them.

You could consider a discount for stores that have coin/token devices installed to encourage trolley returns

The retailers who have shopping trolleys ultimately responsible for them, leaving their premises and should prevent them from leaving by means of the wheels lock off when they leave their property, so the trolley cannot be moved leave at the property

Supermarkets should be charged at least 20% more if they cannot be bothered to recover themselves.

Would it be legal to impose a fine for the worst supermarket offenders? As I understand some supermarkets do not want to pay £100 per trolley. Maybe if it was £50

Repurpose them in the community.

The onus should be on the supermarket to collect their trollies from your storage within a week. If left longer then an additional storage cost added or trolley. There are repeat 'offenders' that take the trollies out of the supermarkets who could be fined for doing so. I don't know how this would be 'policed'. Supermarkets should use trollies where the wheels lock when taken outside their perimeter.

Do you have any other comments you would like to add?

There are cost effective ways of stopping shopping trolleys going off site. If supermarkets won't implement these then I think you should charge a hell of a lot more than £100. It's not clear if it's per trolley or for trolleys. But should be more.

Ultimately, the supermarkets are paying for the problem that our local residents are causing. It isn't wholly fair for them to have to pay when residents who should know better are the ones causing the problem by taking trolleys away from the store - hence my suggestions for enforcement of smartstop trolleys as once the initial outlay has been made the act of removing trolleys from the stores carpark boundary becomes much harder.
