RECOMMENDATION(S):

- 1 Corporate Policy and Resources Committee agree to accept the award of funding once received for Warm Homes Local Grant from Midlands Net Zero Hub (MNZH) and authorise signing of the grant funding agreement by Section 151 Officer, for return to MNZH.
- 2. Create a new capital scheme in the Capital Programme and create a capital and revenue budget for the WHLG once funding agreement has been signed.

MNZH will issue a grant funding agreement to the Council which will include all details of the funding which is to be allocated to the Consortium for Warm Homes Local Grant. As accountable body, to the Central and South Lincolnshire Consortium, WLDC will seek a review of the grant funding agreement by Legal Services Lincolnshire.

The Council will need to ensure that WHLG Delivery proposal is compliant with UK subsidy control rules. This will be reviewed by legal service Lincolnshire as part of the contracting procedure.

All procurement activity will be undertaken in line with the Council's Contract Procedure Rules (CPRs) and ultimately Public Contract Regulations 2015 (PCRs), which is embedded into UK Law. All frameworks which the Council are using and may consider using are PCR compliant.

Financial: FIN/153/25/SL/MT

Committee are asked to approve the signatory of the Grant Funding agreement, due to the value of the contract – indicative allocation for West Lindsey District Council £1,356,919, with final allocation due to be confirmed in March 2025.

This project relies on securing of capital grant funding via Department of Energy Security and Net Zero (ESNZ) of £9mil to deliver the WHLG scheme.

Admin allocation to be used for the Energy Efficiency Project Officer (subject to job evaluation) hosted by West Lindsey District Council (WLDC). This will be a 36-month contract.



Executive summary

Midlands Net Zero Hub (MNZH) have submitted an expression of interest to the Department for Energy, Security and Net Zero (DESNZ) for Government funding through Warm Homes Local Grant (WHLG) on behalf of the Central and South Lincolnshire Consortium comprising of West Lindsey, North Kesteven, City of Lincoln and South Kesteven Councils.

An indicative allocation of £9,140,000.00 has been allocated to the consortium to deliver the new grant initiatives under the WHLG scheme. We are awaiting confirmation of the exact allocation of funding which we expect in mid to late March 2025.

It is intended that funding secured from DESNZ will be used to carry out a range of improvements on homes owned by low-income families in the district – making them warmer, reducing energy bills, and improving the quality of citizens' lives.

A decision is required to accept the grant award once received, and sanction return of the grant funding agreement from the S151 Officer.

This approval will enable delivery of the scheme to start immediately, with installations commencing as soon as contracts are in place, and release spend from the administration allocation which will fund the Energy Efficiency Project Officer post hosted by WLDC.

1: Warm Homes Local Grant

- 1.1 The Government have committed to a Warm Homes Plan to upgrade five million homes over next five years to cut bills for families and deliver warmer homes to slash fuel poverty.
- 1.2 This ambition is a key part of the Government's 'second mission' to transform Britain into a clean energy superpower, including providing the country with clean energy by 2030, reducing bills, and transitioning homes to clean heat as part of the wider ambition to reach net zero by 2050.
- 1.3 As a key part of the Warm Homes Plan, the Government has committed to partnering with combined authorities, local and devolved governments to deliver insulation measures and other improvements such as solar panels, batteries and low carbon heating to cut bills for families, slash fuel poverty, and reduce carbon emissions in support of our net zero 2050 target.
- 1.4 The Warm Homes: Local Grant is a government-funded scheme delivered by Local Authorities that will take the first steps to delivering on the ambitions of the Warm Homes Plan.
- 1.5 The Warm Homes: Local Grant will begin delivery in 2025 and will provide energy performance upgrades and low carbon heating via local authorities, to households that:
 - are in England
 - are low income
 - have an Energy Performance Certificate (EPC) between D and G
 - are privately owned (owner occupied or privately rented)
- 1.6 Once in delivery local authorities will be able to install energy performance measures and low carbon heating to eligible homes in their area. Measures could include:
 - insulation
 - solar panels
 - an air source heat pump if suitable
- 1.7 Upgrades should be tailored to individual homes so that the most appropriate measures are installed. Occupants on a low income will not contribute to the cost of upgrades.
- 1.8 These upgrades will be open to all fuel types, including on gas households (those heated by mains gas), and off gas households (those heated by electricity, oil, coal, or liquid petroleum gas).
- 1.9 All eligibility criteria and eligible works that are to be undertaken through this grant scheme are set by Central Government and cannot be dictated by Local Authorities. West Lindsey will be administering this scheme on behalf of Central Government and can not make any decisions on the eligibility of applicants or the measures that are covered through the grant. More detail about the scheme itself can be found at this link Warm Homes: Local Grant GOV.UK

- 1.10 To support delivery of the Warm Homes Plan, the primary and a secondary objectives of the Warm Homes: Local Grant are:
- 1. To deliver progress towards the statutory fuel poverty target for England, by improving as many fuel-poor homes as reasonably practicable to energy efficiency rating of Band C by 2030, delivering significant annual energy bill savings for the occupants, not just in the short term, but for good.
- 2. To deliver progress towards Net Zero 2050, and the Carbon Budgets, by installing energy performance upgrades and low carbon heating in homes that drive carbon abatement.
- 1.11 Alongside those leading objectives, the Warm Homes: Local Grant will help to ensure homes are healthy living environments, thermally comfortable, efficient and well-adapted to climate change. It will also support the green economy, local supply chains, and skilled jobs for tradespeople in every part of England.
- 1.12 By focusing on low-income households and areas of high economic deprivation, upgrades made to the housing stock will support deprived communities throughout England, ensuring that they are not left behind in the transition towards Net Zero, but instead lead the way.

2: Background

2.1 Central and South Lincolnshire Consortium formed to deliver the Sustainable Warmth Competition (SWC) grants (LAD3/ HUG1) and HUG2 in 2022. Due to the success of the scheme, good working relationships formed, and following approval from MT in November 2024, submission of the expression of interest was submitted as a consortium for WHLG funding.

3: Warm Homes allocation, delivery, and timeframes

3.1 The total indicative allocation for Central & South Lincolnshire Consortium is £9,140,000, which includes an allocation for West Lindsey District Council of £1,356,919. The table below outlines individual districts indicative allocation for each consortium member.

10% of the allocation can be used for Admin & Ancillary purposes.

- 3.2 For SWC and HUG2 a delivery partner was appointed via the Fusion 21 Framework to provide a full turnkey delivery service, and installation of energy efficiency measures. We propose to go with a similar approach to deliver the new grants.
- 3.3 Once delivery has commenced, we propose to explore options for delivery of the service which would enable us to have more influence in delivery, quality checks, monitor applications more closely, and continue the success of the home energy advice officers, promoting initiatives at relevant events to partners and residents across Lincolnshire.
- 3.4 There is a risk if we implement a new way of working at the beginning of the scheme, that there would not be enough capital grant funding spent to draw down funding to cover the costs of additional staff. Remaining with the delivery partner model in the first 6-12 months will allow us to expedite delivery of grants while exploring options for greater influence over delivery for the further years of the grant funding.
- 3.5 It is proposed to extend the current Energy Efficiency Project Officer role for a further 3 years, funded by the administration allocation to deliver this scheme. This will be hosted by WLDC. A new job description and person specification have been drafted to capture the potential of future staff management, the post will be subject to job evaluation and therefore the costs could change. The table below outlines costs at the current band 7, and band 8.

- 3.6 As with previous initiatives, it is expected MNZH will require the Council to submit a delivery plan, outlining how it intends to allocate the Warm Homes Grant to fuel poor households in the Consortium Districts. The Delivery plan must set out the number of properties, type of measures and cost of the retrofit works the council expects to be able to deliver within the parameters of the grant guidance. As the lead authority, this will be led and submitted by WLDC but the plan will be drafted by the consortium as a whole.
- 3.7 The Council will be expected to submit monthly reports to MNZH on progress delivery. Delivery of WHLG will also be monitored via KPl'S, Housing and Wellbeing Programme Board, and quarterly capital expenditure via CP&R.

3.8 There has been positive changes to delivery guidance, one major change includes landlords will now be eligible for one property to be retrofitted free of charge, any subsequent properties require a 50% contribution.

4 Decision and Next Steps

- 4.1 Once the allocation has been confirmed WLDC will be required to sign and return a grant funding agreement. There will be a very short turnaround for this, as such, we are asking members as part of this report to agree to sign that agreement once its is received. We will then have to submit a delivery plan to MNZH which will enable the delivery assurance check to be completed and allow for commencement of grant funding delivery to begin.
- 4.2 In previous schemes, on signing the grant funding agreement, the council will receive 10% admin and ancillary costs, followed by a 15% deposit payment (after Delivery Assurance Check approval by MNZH).
- 4.3 A decision is being requested to seek approval for signing and returning the grant funding agreement once it is received.

Recommendations
