Black	motion to council	<p>extract from mins of meeting 20/01/20</p> <p>I would ask Council to require all public firework displays within the local authority boundaries to be advertised in advance of the event, allowing residents to take precautions for their animals and vulnerable people and to actively promote a public awareness campaign about the impact of fireworks on animal welfare and vulnerable people – including the precautions that can be taken to mitigate risks.</p> <p>and</p> <p>that the Council ban the release of sky lanterns from council owned or operated sites in West Lindsey and include information about the dangers of sky lanterns as part our public awareness campaign"</p>	<p>There doesn't appear to be any directly linked regulation that can stop it and the use of a PSPO would seem disproportionate in this context. For example, the authorities may own open space or venues used for events or weddings, at which lanterns are let off.
