
It was established that this male was who had no right to work. Illegal working interview carried out with Tamil interpretor on the telephone.


Once this male had been spoken with he was let on his way. We returned to the shop to continue the compliance check. The second male from earlier had left my the time I arrived and a different staff member was present.

Staff not able to access Cctv.


