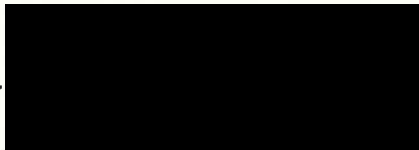
A separate register of members' interest form is required for each Authority that you may be a member of.
