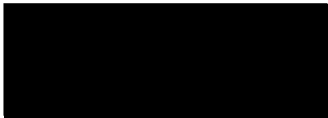
This notice must be returned either within 28 days of the Authority's Local Code of Conduct being adopted or within 28 days of your election or appointment to office.
